The owner shall, at his own expense, insure and keep insured against all risk of loss and damage, all equipment rented to Okanagan Aggregates Ltd. and shall, also at his own expense, carry and maintain liability insurance against Third Party claims arising from ownership use, or operation of machinery or apparatus, (including its equipment), mounted on or attached to any equipment, with inclusive limits of not less than \$2,000,000 for bodily injury, including death and property damage. The owner shall be solely responsible for all damages occurring to the rental equipment and for injury to persons or to property, arising out of the use, possession, or transportation of the equipment, and shall indemnify and save harmless Okanagan Aggregates Ltd. from and against all claims and demands, loss or damages.

*Note: All insurance policies must contain a waiver of subrogation clause that in the event of any third party loss or damage or physical loss or damage to the equipment the settlement or payment of the subsequent claim shall be made without the right or subrogation against Okanagan Aggregates Ltd. or any of its employees.*

All equipment and operators must comply with the current Motor Vehicle Act and Regulations.

It is expressly understood that the owner/operator under this agreement shall comply with all safety requirements and regulations of Okanagan Aggregates Ltd.

All equipment rented to Okanagan Aggregates Ltd. must conform with the requirements of the current Workers' Compensation Board Industrial Health & Safety Regulations, including the maintenance of required log books.

All companies or sole proprietors must be registered with WCB & provide a clearance letter or we will hold back 10%.
